FUNDRAISING REQUIREMENTS

As a registered runner I pledge to raise a minimum of \$1,250 no later than October 1, 2021 for the Crossroads Runners. _____ (Initials)

I also understand that the Crossroads Runners is an important fundraising initiative of Old St. Pat's. If I run the Chicago Marathon and my best fundraising efforts do not result in at least \$1250/ by October 1, 2021, the Crossroads Runners is authorized to charge any 'shortfall' (that is, any amount less than \$1,250) to my credit card that I provided in the registration. If the credit card is declined for any reason, I agree to make the payment by cash or check within 30 days of the decline.

INJURY CLAUSE

If I withdraw from the race or Crossroads Runners Charity Team due to injury and have not completed my agreed upon fundraising minimum of \$1,250, I authorize Old St. Patrick's Church to charge my credit card the registration and organizational fee of \$500. The \$500 will be used to offset the Crossroads Runners expenses incurred. _____ (Initials)

If I have already raised at least \$500 for the Crossroads Runners, all such proceeds (raised in the name of the Crossroads Runners or Old St. Patrick's Church) shall remain with the Crossroads Runners.

If I have not done any fundraising by the time I declare I am unable to run the Chicago Marathon (or if I have raised less than \$500), the Crossroads Runners and Old St. Patrick's Church is authorized to charge any 'shortfall' (that is, any amount less than (\$500) to my credit card. If the credit card is declined for any reason, I agree to make the payment by cash or check within 30 days of the decline.

PUBLICITY CLAUSE

I grant perpetual, reality-free license to the Crossroads Runners and Old St. Patrick's Church to use my name, image and/or likeness for the purpose of promoting the Crossroads Runners in any manner worldwide - printed material, radio or television broadcast or online, in any manner whether presently in existence or hereinafter developed. _____ (Initials)

REGISTRATION CLAUSE

I acknowledge that my registration for this charity team (Crossroads Runners – Old St. Patrick's Church) is separate from event registration for the Chicago Marathon (a link will be sent to you to register for the Chicago Marathon). _____ (Initials)

I also acknowledge that my guaranteed charity entry into the 2021 Chicago Marathon is non-transferable and cannot be deferred unless the 2021 Marathon is cancelled. In case of a 2021 cancellation, my registration will be deferred to 2022 and I will be responsible for the fundraising minimum at that time. _____ (Initials)

WAIVER AND RELEASE OF LIABILITY

I acknowledge that I have voluntarily agreed to participate as a Crossroads Runner in the 2022 Bank of America Chicago Marathon. I agree that I and/or my heirs, guardians, legal representatives, successors, distributes, and assignees will not make a claim against, sue, attach the property of, or prosecute The Crossroads Group or any of its affiliated organizations, staff, Old St. Patrick's Church, the Crossroads Runners, Board or agents for any losses, injury, death or property damage occurring to me as a result of my participation (either directly or indirectly) in any of the activities related to training and running with the Crossroads Runners whether caused by negligence of Crossroads Runners, or otherwise. _____ (Initials)
